As a barrister since 1997 and Senior Counsel since 2009, I have extensive experience as a trial and appellate advocate, with expertise in **public law** (in particular, judicial review and regulatory action), **commercial law** (consumer law, contractual disputes and class actions), **intellectual property, media and technology** (in particular, copyright and trade mark disputes and regulation of media and technology), and **environmental and planning law** (in all classes of the jurisdiction of the NSW LEC and in the Federal Court in judicial review).

I regularly appear in trials and appeals in the Federal Court of Australia, the Supreme Court of NSW and the Land and Environment Court of NSW. I have appeared on multiple occasions as the advocate in appeals and special leave applications in the High Court. I have extensive experience in commercial arbitrations throughout Australia, including in current matters in Western Australia and the Northern Territory.
